- 1. A continuación se detalla una primera aproximación al proyecto denominado "Las Vegas 2002".
- 2. Este proyecto podría tener lugar la tercera semana de marzo de 2002 (lunes 18 al viernes 22 de marzo).
- 3. El objetivo del proyecto se puede dividir en 2 áreas principales:
 - Ciudades & Desierto: esta primera etapa del proyecto se orienta a profundizar el conocimiento y las soluciones implementadas en las ciudades de sectores desérticos de USA, tales como Tucson, Phoenix, Scottsdale y Sedona (todas ubicadas en Arizona), o Reno y Las Vegas (ubicadas en Nevada).

El know how derivado de las visitas puede ser vinculado y potenciado en la agenda de la CChC, particularmente en lo relativo al desarrollo del desierto y del norte chileno.


- American General Contractors (AGC): aprovechando la estadía en Las Vegas se puede asistir a la 83ava. Convención Anual del AGC que además coincide con la Exposición Conexpo/Conagg, estableciendo contactos y vinculaciones con el mundo de la construcción que asiste a estos eventos.
- 4. El área **Ciudades & Desierto** podría ser cubierta los días lunes 18 y martes 19 de marzo de 2002 visitando alguna de las ciudades propuestas y estableciendo una agenda de reuniones ad hoc.

 - El suministro y manejo del recurso agua en Arizona también es destacable. De hecho existe un proyecto sumamente interesante llamado CAP (Central Arizona Project) channels que permite el suministro de agua a las ciudades importantes.

- En Phoenix se está buscando solución a problemas derivados de la contaminación ambiental y de la congestión vehicular.
- El concepto de "Grow Smart" está siendo aplicado en las principales ciudades frente a las altas tasas de crecimiento.
- La cercanía de Phoenix a Los Angeles (Interstate 10) ha estimulado la creación de una amplia malla de centros de distribución.
- Scottsdale, suburbio ubicado al este de Phoenix, ha crecido enormemente en el mercado de oficinas.
- Tucson ha desarrollado importantes industrias relacionadas con la defensa, el cobre y manufacturas ópticas. Esto ha agregado 200.000 empleos en los últimos 10 años.
- Tucson está re-desarrollando su zona céntrica mediante un proyecto de uso mixto llamado Río Nuevo (62 acres ubicados en pleno centro de la ciudad; MMU\$757 en 20 años).
- Las Vegas ha logrado soluciones interesantes para desarrollar proyectos negociando con minorías étnicas que han manifestado inicialmente oposición a los mismos.
- En el área AGC la entrada tiene un valor de US\$ 625 y da derecho a asistir a todas las exposiciones y reuniones de la Convención, además de la Exposición Conexpo/Conagg.


